### LS Oak Cliff Elementary Parental Involvement Policy

### PART I. GENERAL EXPECTATIONS

The <u>Life School Oak Cliff Elementary</u> agrees to implement the following statutory requirements:

- 6. The <u>Life School Oak Cliff Elementary</u> will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
  - Sending parents a copy of their child's STAAR scores by the student or by mail.
- 7. The <u>Life School Oak Cliff Elementary</u> will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
  - the state's academic content standards,
  - the state's student academic achievement standards,
  - the state and local academic assessments including alternate assessments,
  - the requirements of Part A.
  - how to monitor their child's progress, and

- how to work with educators:

- o Flash Friday Parenting Tips
- The <u>Life School Oak Cliff Elementary</u> will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
  - o Parenting Night
  - o Flash Friday
  - o Classroom Letters
  - o Parent-Teacher Conferences
- 8. The <u>Life School Oak Cliff Elementary</u> will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
  - Parent Night
  - View and discuss the "Value and Contribution of Parents" with teachers and staff
  - Tips in Flash Friday
- 9. The <u>Life School Oak Cliff Elementary</u> will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
  - Assisting in providing these programs if the parents request them.
- 10. The <u>Life School Oak Cliff Elementary</u> will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
